



## CEO Letter to All APTA Members

October 15, 2020

Dear APTA Members,

This week, we have been preparing for vitally important meetings of the Board of Directors (Oct. 20) and TRANScend, our first-ever virtual year-end event (Oct. 21-22). Please watch for *Passenger Transport's* special TRANScend Conference issue, which includes a two-page spread on APTA's Annual Award winners and a commentary by APTA Chair Nuria Fernandez about her 2021 priorities.

### TRANScend

TRANScend will focus on the biggest issues facing public transit. Topics include the long-term impacts of COVID-19, bringing riders back, putting equity in the forefront, the changing landscape of cities, and policing in a new era. Plus, we'll hear from keynote speakers Tony Seba and Eddie Glaude Jr.

### Advocacy

- **Yesterday, APTA released a [statement](#) expressing strong opposition to restrictive eligibility criteria** for COVID-19 Transit Research Demonstration Grants. FTA announced it will consider applications in accordance with White House guidance that prohibits federal funds to “anarchist jurisdictions.”

According to the Administration, New York, NY, Portland, OR, and Seattle, WA are “anarchist jurisdictions.” These grants are critical for public transit systems that are undertaking extraordinary efforts to safeguard riders and employees from the coronavirus, while facing unprecedented budget pressures. - **APTA continues to aggressively advocate for \$32 billion in additional COVID-19 emergency funding.** These funds are part of a House-passed \$2.2 trillion package called “The Heroes Act.” While prospects for a House-

Senate-Administration agreement appear unlikely before Nov. 3, we continue to push for this funding in any COVID-19 or funding legislation. We remain committed to this issue after the Nov. 3 election in a “lame-duck” session of Congress – and beyond, if necessary. See the *Washington Post* article with my quote [here](#).

CFO John Henry and I reported on the financial impact of COVID-19 on APTA's operations and the FY 2021 Budget. The committee discussed options to mitigate the revenue shortfall facing APTA.
- **APTA's Executive Committee** met on Oct. 14 to discuss the association's financial outlook through 2021 and beyond. Committee members are committed to ensuring APTA remains responsive to the changing economic and social needs of our members.
